

**Bulkley Valley Rod and Gun Club
Sportsman's Sale and Gun Show
Rules for Exhibitors**

1. All Federal, Provincial and Municipal laws must be observed. Including, but not limited to purchasers of firearms and/or ammunition must have a valid PAL. The PAL must not be expired and must have the correct endorsement for the firearm being purchased. This is the responsibility of the vendor. For more information see www.cfc.gc.ca.
2. No selling of guns, ammunition or knives to persons under 19 years of age. **Check ID!!!**
3. All firearms must be secured to avoid removal and/or being loaded and fired. All firearms must have trigger locks, or have "Zap Straps" to disable the firearm. Restricted, prohibited and/or handguns must be either in a locked display case or cable locked to the table. Do not allow anyone to handle a firearm in an unsafe manner.
4. No ammunition (live, dummy, "snap caps") is to be loaded into any firearm for any reason.
5. Black powder is not permitted at the show. Smokeless powder must be in factory containers.
6. A written receipt (will be supplied by the club) for security purposes must accompany all firearm sales. No one will be allowed to remove firearms from the building during the show without a sales receipt. Firearm serial numbers must be on the receipt.
7. There will be volunteers at the event but security of your table and property that you bring to the show is YOUR responsibility. The Bulkley Valley Rod and Gun Club including its members, directors or volunteers are not liable to any Exhibitor, their partner, helpers or guests for any damage whatsoever, including but not limited to damage to any part of any vehicle. The driver and/or owner of a vehicle and the Exhibitor are jointly and severally liable for any damage to the building, exhibit tables, contents of the building or any other damage whatsoever.
8. This is an outdoor sports show – not a garage sale of all things. The BV Rod and Gun Club reserves the right to choose what may be displayed. If in doubt please contact us prior to registration. Once registration and payment are confirmed, it is nonrefundable.
9. Exhibitors can display signs on the walls and tables etc., but must not encroach on other Exhibitors table.
10. If an exhibitor has display items that are not for sale, but will be of general interest to attendees, please ensure they are clearly marked as such to avoid confusion.
11. Exhibitors will be provided with name cards and lanyards/badges. All exhibitors must wear it at all times during the event.
12. Setup will be available from 7am to 9am the morning of the show. Exhibitors must stay until at least 1:00pm and no later than 3:00pm.
13. All tables must have a cover supplied by the exhibitor. This is to maintain an air of professionalism at the show. It is preferred that the cover extends to the floor at the front of the table.
14. The Bulkley Valley Rod and Gun Club assumes no responsibility for the quality or functionality of any item purchased or traded at the show. All issues or questions should be directed to the sellers, we are strictly a venue.

We are anticipate a fun event with good exchange of goods and conversation. At the end of the show we appreciate constructive feedback so that we can make it better for next year.
